JOB SUMMARY

Sprayground/Concession Attendants are responsible for performing a variety of duties to prepare the Sprayground area for the demands of the patrons, daily supervision, and enforcing sprayground rules. This position is also responsible for working in the concession stand and handling money. Must be available: Late May through August/September, Days, Evenings, Weekends, and Holidays (mandatory). Locations: Riverside Park and East Roswell Park.

Tasks may involve extended periods of time outdoors. Tasks also require the ability to perceive and discriminate colors or shades of colors, depth, texture, and visual cues or signals. The work requires the ability to communicate orally and at loud volume if needed.
