

IMPORTANT NOTICE

Your 2023-2024 Alcoholic Beverage license expires at midnight on December 31, 2024.

Please take note that failure to have your license renewed by this date will require you to re-apply for a <u>new license</u> and appear before the Alcohol Beverage Licensing Board before you can serve or sell alcohol in your establishment. The earliest available meeting will be held the first Thursday in January 2025.

THIS MEANS IF YOU DO NOT RENEW BY DECEMBER 31, 2024, YOU WILL NOT BE ABLE TO SELL ALCOHOL <u>AT ALL</u> UNTIL THE NEW LICENSE IS ISSUED.

Any renewal application not filed on or before the last City business day **prior** to October 31, 2024 may be assessed a late filing penalty of \$250.00.

Payment in full is required with the submission of the renewal application.

NOTICE & AFFIDAVIT TIPS (Training Intervention Procedures)

Chapter 3, Article 3.2, Section 3.2.10 of the Alcoholic Beverage Ordinance of the City of Roswell requires certification of the licensee of a restaurant, convenience store, grocery store and package store by attendance at TIPS (Training Intervention Procedures Program) or approved alternative program that shall be verified and signed off by the Chief of Police.

The applicant shall have 6 months from the date of the granting of the license to complete such training and submit certification to the Alcohol Beverage Licensing Board.

The Roswell Police Department will not be offering TIPS Classes at this time. Please choose an online program below. Once completed, please provide a copy to the legal office to be placed in our individual file.
